Re: Rating Letter for BLR of Sindhu Trade Links Limited

India Ratings and Research (Ind-Ra) has maintained Sindhu Trade Links Limited's Long-Term Issuer Rating in the non-cooperating category. The issuer did not participate in the rating exercise despite continuous requests and follow-ups by the agency. Therefore, investors and other users are advised to take appropriate caution while using these ratings. The rating will continue to appear as 'IND D(ISSUER NOT COOPERATING)' on the agency's website. Note: ISSUER NOT COOPERATING: The ratings were last reviewed on 1 September 2021. Ind-Ra is unable to provide an update, as the agency does not have adequate information to review the ratings.
